**MEMORANDUM AND NOTICE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

MODERN HC PHARMACY, INC., a Delaware corporation ("MHCP") and BIOFUSION, LLC, a California limited liability company ("BioFusion"; BioFusion and MHCP, each individually, the "Debtor" and collectively, the "Debtors"), each of whose address is 110 East Huntington Drive, Monrovia, California 91016 hereby acknowledge that, pursuant to the Agreement (defined below), they have granted to BANK OF THE WEST, a California corporation, as agent ("Secured Party"), whose address is 4400 MacArthur Boulevard, Suite 150, Newport Beach, California 90026, a security interest in and to all of the Debtors' right, title and interest in and to: (a) the trademarks and trademark registrations and applications therefor which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by the Debtors (the "Trademarks"), together with the goodwill and assets of the business; to which such Trademarks are appurtenant and all actions for infringement concerning the foregoing.

The terms and conditions of the aforementioned security interest are contained in that certain Loan and Security Agreement dated as of July 24, 2012 (the "Agreement"), entered into among Debtors, Modern HC, Inc., a Delaware corporation, ModernHEALTH specialty (PC), LLC, a Delaware limited liability company, ModernHEALTH Specialty (AD-RX), LLC, a Delaware limited liability company and Secured Party, as security for the obligations as set forth in the Agreement and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Secured Party may have in any other collateral described in the Agreement or otherwise.
