TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment") is made effective as of June 18, 2012, by and between Zap-Lok Pipeline Systems, Inc., a Massachusetts corporation, having a usual place of business at 12100 W. WITNESSETH:

WHEREAS, Assignor is the owner of the trademarks, trademark applications, and trademark registrations (whether singular or plural), including the goodwill symbolized thereby, set forth on Schedule A attached hereto and incorporated herein by reference (hereinafter the "Marks and Registrations", respectively);

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated June 18, 2012 (the "Purchase Agreement"), pursuant to which Assignor transferred, sold and conveyed to Assignee certain assets of Assignor, including the Marks and Registrations; and

WHEREAS, Assignee is desirous of acquiring all of Assignor's right, title, and interest in and to the Marks and Registrations.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby sell, convey, assign, transfer, and set over to the Assignee, Assignor's entire right, title, and interest in and to the Marks and Registrations, together with the goodwill of Assignor's business in connection therewith, and the full right to sue for past, present or future infringement of any of such Marks and Registrations, these rights to be held and enjoyed by the Assignee, its successors and assigns, as fully as the same would have been held and enjoyed by the Assignor had this assignment not been made (including but not limited to, all registration rights with respect to the Marks and Registrations, and the right of claiming for itself the priority of filing of applications for the registration of the Marks and Registrations in other countries of the world, in accordance with Article 4 of the International Paris Convention (1883), and any other applicable convention and/or treaty).

The Assignor agrees that when requested by the Assignee it will cooperate and use commercially reasonable efforts to, at the sole cost of the Assignee, execute or have executed all documents necessary or desirable to properly vest full right, title and interest in and to the Marks and Registrations in the name of the Assignee or its designee or which, in the reasonable judgment of the Assignee, may be necessary to obtain, maintain, issue or enforce said Marks and Registrations.

Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and Registrations and title thereto as the property of Assignee, its successors, assigns or legal representatives in accordance with the terms of this instrument.

Assignor and Assignee agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Assignor and Assignee.

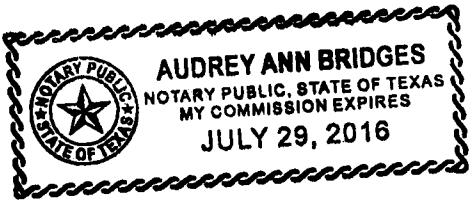

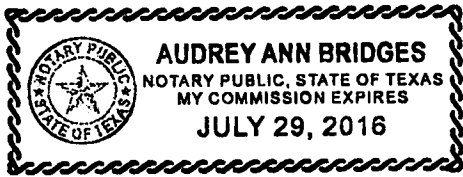

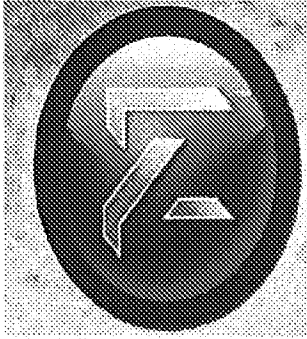
