**RELEASE OF IP
SECURITY AGREEMENT**

WHEREAS, pursuant to that certain IP Security Agreement, dated as of November 1, 2006 (the "Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 3423, Frame 0423 and Reel 18490, Frame 0598, MTE Corporation ("Releasee"), granted to Bank of America, N.A. as collateral agent, ("Releasor"), a security interest in and continuing Lien on the Collateral, including the Intellectual Property described on Schedules A and B attached hereto; and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of Releasor's security interest in and continuing Lien on the Collateral and the assignment and transfer to Releasee of all of Releasor's rights in and to the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby, without any representation and warrant and without any recourse to Releasor, releases, relinquishes and discharges its security interest in and continuing Lien on the Collateral and assigns and transfers to Releasee all of Releasor's rights in and to the Collateral.
