THIS DEED is made on 9 January 2012

**BETWEEN:**

- (1) **THE OUTDOOR GROUP LIMITED (IN ADMINISTRATION)**, a company incorporated in England and Wales with registered number 00507794 and whose registered office is at 440-450 Cob Drive, Swan Valley, Northampton NN4 9BB (the "Assignor") acting by its administrators Brian Green, David Costley-Wood and Richard Fleming of KPMG LLP (the "Administrators");
- (2) **THE ADMINISTRATORS**; and
- (3) **AGHOCO 1070 LIMITED**, a company registered in England and Wales under number 07795258 whose registered office is at Hollinsbrook Way, Pilsworth, Bury, Lancashire BL9 8RR (the "Assignee").

**WHEREAS:**

- (A) The Assignor is the registered proprietor of the Registered Marks and has certain rights, title and interests in and to the Unregistered Marks and the Other IPR.
- (B) The Assignor is also the registrant of the relevant Domain Names.
- (C) Pursuant to the Business Purchase Agreement, the Assignor has agreed to assign such right, title and interest as it may have in and to the Registered Marks, the Domain Names, the Unregistered Marks and the Other IPR to the Assignee on the terms and conditions of this Deed.

**IT IS AGREED** as follows:

**1. DEFINITIONS AND INTERPRETATION**

**1.1** In this Deed (including its Recitals and Schedules), the following words and expressions shall have the following meanings:

| <b>BLG IP Assignment</b> | the intellectual property and domain name assignment entered into on the same date as this Deed between Blacks Leisure Group plc (in Administration), the Administrators and the Assignee; |

**Business Purchase Agreement** the agreement entered into on January 2012 between amongst others Blacks Leisure Group plc (in administration), the Assignor, the Administrators, the Buyer and JD Sports Fashion plc (as guarantor) in respect of the acquisition of the Businesses by the Buyer;

**Domain Names** the domain names listed in Schedule 2 to the extent not otherwise assigned to the Assignee pursuant to the BLG IP Assignment;

**Domain Name Transfer Formalities** all formalities, including carrying out all actions and, where necessary or appropriate, the completion and execution of documents that are required to transfer the Domain Names and registrations thereof to the Assignee, including the change of registrant name to the name of the Assignee or its nominee, change of administrative contact to refer to a contact elected by the Assignee and, where required by the Assignee, change of registrar;

**Other IPR** all Intellectual Property Rights owned by or (where the licences are capable of being transferred) licensed to the Assignor at the Asset Completion Date to the extent not otherwise assigned pursuant to this Deed, including the Computer Software and all Intellectual Property Rights owned by the Assignor in the Website Content;

**Party** a party to this Deed;

**Registered Marks** the registered trade marks listed in Part A of Schedule 1; and

**Unregistered Marks** the unregistered marks illustrated in Part B of Schedule 1.

1.2 Capitalised terms used in this Deed shall, unless otherwise defined, have the meanings ascribed to them in the Business Purchase Agreement.

1.3 In this Deed, any reference to:

1.3.1 a "clause", "Schedule" or "paragraph" is (unless otherwise stated) to a clause of or Schedule to this Deed or to a paragraph of the relevant Schedule.

The Schedules form part of this Deed and shall have the same force and effect as if expressly set out in the body of this Deed; and

1.3.2 the singular shall include the plural and *vice versa*.

1.4 For the purposes of this Deed, "**holding company**" and "**subsidiary**" shall have the meanings ascribed to them in s.1159 of the Companies Act 2006.

1.5 The clause headings in this Deed are for ease of reference only and shall not affect its interpretation.

## 2. ASSIGNMENT

2.1 In pursuance of and for the consideration referred to in the Business Purchase Agreement, the Assignor hereby assigns to the Assignee:

2.1.1 all the right, title and interest that it has in and to the Domain Names and the Assignor agrees to carry out the Domain Name Transfer Formalities as soon as reasonably practicable following the date of this Deed;

2.1.2 all the right, title and interest that it has in and to the Registered Marks (including all statutory and common law rights appertaining to them and the right to sue for past infringements) and all goodwill relating thereto which it has accrued relating to the services in respect of which each Registered Mark is registered;

2.1.3 all the right, title and interest that it has in and to the Unregistered Marks (including all statutory and common law rights appertaining to them and the right to sue for past infringements) and all goodwill relating thereto which it has accrued; and

2.1.4 all the right, title and interest that it has in and to the Other IPR, including (to the extent that the Assignor has the right to or the right to do the following):

2.1.4.1 the right to bring, make, oppose, defend or appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement of the Other IPR whether occurring before, on or after the date of this Deed;

2.1.4.2 any goodwill associated with the Other IPR;

2.1.4.3 all rights to apply for registered rights or protection of the Other IPR in any country in the world; and

2.1.4.4 all rights to claim priority in the Other IPR and all rights to any extensions, renewals or amendments of or to the Other IPR.

### 3. FURTHER ASSURANCE

3.1 The Assignor and the Administrators shall at the request and cost of the Assignee, provided they are reasonably able to do so and for a period of 12 months from Completion or, in the case of the Administrators, for as long as they are in office (whichever is the earlier):

3.1.1 promptly execute and deliver such further documents and undertake and do such things as may be reasonably necessary for the purpose of transferring to the Assignee such right, title and interest as the Assignor may have in and to the Assigned Assets or any of them subject to approval of any wording by the Administrators and the Administrators' Solicitors; and

3.1.2 use reasonable endeavours in order to give full legal effect to the assignment of such right, title and interest that the Assignor may have in any of the Assigned Assets as is contemplated under the terms of this Deed.

3.2 Where i) the Assignor and or the Administrators are required to undertake any matter pursuant to this clause 3 or as otherwise requested by the Assignee or required in each case under the terms of this Deed or ii) the Assignor and or the Administrators are required to procure any action by a third party, the Assignee shall first procure that monies are paid in advance in respect of the Assignor's, Administrators' and third party's (as appropriate) costs which are likely to be incurred in respect of such action. Neither the Administrators nor the Assignor shall be required to take or procure any action pursuant to this clause 3 or as otherwise requested or required under this Deed until such time as the Assignee has advanced, and the Administrators, Assignor or relevant third party (as appropriate) has received, such monies as the Administrators or Assignor determine (acting reasonably) is necessary in order to discharge such anticipated costs.

3.3 The Administrators shall following Completion only be required to take such further action and steps and execute such further documents, transfers or deeds as contemplated by this Deed on the basis that the Administrators' personal liability is expressly excluded.

### 4. LIMITATIONS OF LIABILITY

4.1 The Parties hereby acknowledge and agree that the Administrators act as agents for the Assignor in entering into this Deed and are a party to this Deed in their personal capacity only for the purpose of receiving the benefit of this Deed and that, subject to clause 4.2, neither the Administrators nor their firms, staff, employees, agents, group undertakings or advisors shall incur any personal liability under this Deed or under or in relation to any associated arrangements whether such liability would arise under contract, tort, statute or otherwise.

4.2 Nothing in this Deed shall limit or exclude (or purports to do so) the liability of the Assignor or Administrators in the case of fraud.

4.3 For the avoidance of doubt, the provisions of the Business Purchase Agreement relating to the Sale Assets and the exclusions and limitations of liability on the part of the Assignor and the Administrators apply mutatis mutandis to this Deed and the Assigned Assets.

4.4 Nothing in this Deed shall operate to restrict or affect in any way any right of any Administrator to cease to act as Administrator of the Assignor.

5. **ENTIRE AGREEMENT**

This Deed (together with any documents referred to herein or required to be entered into pursuant to this Deed) contains the entire agreement and understanding of the Parties relating to the subject matter of this Deed and supersedes all prior agreements, understandings or arrangements (both oral and written) relating to the subject matter of this Deed and any such document.

6. **COSTS**

Without prejudice to clause 3, each Party shall bear its own costs, fees and expenses in connection with the negotiation, preparation and execution of this Deed, **PROVIDED THAT** all costs, fees and taxes relating to the recordal in the relevant registry of the assignment of the Registered Marks and/or any of the Other IPR assigned pursuant to clause 2.1 will be borne by the Assignee.

7. **COUNTERPARTS**

This Deed may be executed as two or more counterparts and execution by a Party of at least one of such counterparts will constitute due execution by that Party of this Deed.

8. **NOTICES**

8.1 Any notice or other communication to be given in connection with this Deed shall be in writing and (without prejudice to proof that it has been effectively given in any other manner) shall be deemed duly served if sent by fax, or delivered at or sent by recorded delivery post to the address of the Party concerned which is set out in this Deed or such other address for service as that Party may have notified to the other Parties in writing.

8.2 Any notice shall be deemed to be served if sent by fax or delivered personally, on the day on which it is faxed or delivered or, if posted, at 10 a.m. on the second Business Day after the day of posting. Evidence that the notice was properly addressed, stamped and put into the



post shall be conclusive evidence of service.

**9. GOVERNING LAW AND JURISDICTION**

**9.1** This Deed shall be governed by and construed in accordance with the laws of England and Wales.

**9.2** The Parties irrevocably agree to submit to the exclusive jurisdiction of the courts of England and Wales over any claim or matter arising under or in connection with this Deed.
