NOW, THEREFORE, the parties, for One (\$1.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, mutually agree as follows;

1. Assignment of License and Partial Assignment of Trademarks

Assignor does hereby sell, assign, and transfer to Assignee all licensed and assigned rights and interests in the said Trademarks, together with the goodwill of the business symbolized by the Trademarks, and the above-identified


registrations thereof. Said Assignment is binding on the successors, heirs, and assigns of the Assignor and its constituent members.

A. Assignor warrants and represents to Assignee that it is the licensee and partial assignee of the said Trademarks.


