David R. Haarz declares that:


1. I am counsel for Kudelski S.A., a legal entity organized and existing under the laws of **Switzerland**, with its principal place of business at Route de Geneve 22, 1033 Cheseaux-sur-Lausanne, Switzerland and have full access to the file history regarding U.S. Application Serial No. 75827966 that resulted in the issuance of U.S. Registration No. 2605288.
2. This Declaration is being recorded to correct the clerical error by the USPTO which resulted in the issuance of Registration No. 2605288 in the name of "KUDELSKI S.A. (SWEDEN CORPORATION)".
3. On October 21, 1999, Kudelski S.A. filed an application to register the NAGRAVISION (Stylized) mark and that application was assigned Serial No. 75827966.
4. The application assigned Serial No. 75827966, both in the body of the application and on the drawing page attached to the application, identified the applicant as Kudelski S.A., a "Swiss company." Copies of the application and drawing page for Application Serial No. 75827966 are attached to this Declaration.
5. Notwithstanding the fact that Kudelski S.A. was identified as a "Swiss corporation" in the application, when the USPTO issued the Filing Receipt for Trademark Application No. 75827966, Kudelski S.A. was mistakenly identified as "SWEDEN corporation."
6. This mis-identification of Kudelski S.A. as a legal entity under the laws of Sweden was apparently not noted by the attorney prosecuting Application Serial No. 75827966 or the Examining Trademark Attorney when a Response to Office Action was filed on July 17, 2000 and Kudelski S.A. made of record a "certified copy of its home [Swiss] Registration No. 469,288 for NAGRAVISION (Stylized)..." A copy of that Response to Office Action is also attached.

7. At the time Application Serial No. 75827966 was filed there was no corporation or other legal entity named Kudelski S.A. organized and existing under the laws of Sweden.

8. Therefore, the owner of Registration No. 2605288 is and always has been Kudelski S.A. a legal entity organized and existing under the laws of Switzerland.

9. The undersigned being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. Section 1001, and that such willful false statements may jeopardize the validity of the application or any resulting registration, declares that the facts set forth above are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.


