AGREEMENT AND DEED OF ASSIGNMENT

BETWEEN:

1. **ID&Q Licenties B.V.**, a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) under the laws of the Netherlands,, with its corporate seat in Amsterdam, the Netherlands, and its office address at Rhônweg 54, 1043 AH Amsterdam, registered with the Trade Register under number 34162403; (hereinafter referred to as "the Assignor");

And

2. **Q-Licenties V.O.F.**, a general partnership (*vennootschap onder firma*) under the laws of the Netherlands, with its corporate seat in Amsterdam, the Netherlands, and its office address at Rhônweg 54, 1043 AH Amsterdam, registered with the Trade Register under number 34203774, (hereinafter referred to as "the Assignee");

WHEREAS:

- A. Assignor is the owner of the trademark registrations listed in Annex A (these trademark registrations hereinafter referred to as "the Trade Marks");
- B. Assignee wants to obtain the Trade Marks and Assignor is prepared to assign the Trade Marks to Assignee;
- C. For the purpose of this assignment, the parties enter into the current agreement (hereinafter referred to as "the Agreement")

THE PARTIES HAVE AGREED THAT:

1. The Assignor hereby assigns, for the amount of EUR 1 (one), all its right, title and interest in the Trade Marks to the Assignee together with the good will appurtenant to the Trade Marks, and with full title guarantee and free from encumbrances, including, without limitation all rights to bring any proceedings and obtain any remedy in respect of any infringement of the Trade Marks which has occurred prior to the date of this Agreement, which assignment the Assignee hereby accepts.
2. The Assignor shall promptly do all such things as may be reasonably required by the Assignee in order:
 - (A) to confirm the Assignee's ownership of the Trade Marks;
 - (B) to ensure that the Assignee is registered as the registered proprietor of the Trade Marks with the relevant trademarks registries;




- (C) to assist the Assignee to take legal proceedings against third parties in respect of any infringement of the Trade Marks;
- (D) to assist the Assignee to defend any legal proceedings brought by third parties in relation to the use of the Trade Marks.

3. This Agreement is construed according to and governed by the laws of The Netherlands. Any disagreement arising from this Agreement shall be brought before the District Court in Amsterdam, the Netherlands.


