ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks is intended to implement the provisions of the Agreement and shall not be construed to enhance, extend or limit the rights or obligations of Assignor or Assignee thereunder.

This Assignment of Trademarks may be executed in any number of counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.


