NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby freely acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, free and clear of all liens and encumbrances, the entire right, title and interest of Assignor in and to the Mark, together with all of the goodwill of the entire business associated with and symbolized by such Mark, the registration thereof, and all rights and privileges under each of the Mark, including the right to renew and otherwise prosecute the registration of each of the Mark, in the United States and throughout the world., and all rights to recover for damages and profits for infringement in the United States, and throughout the world.

After execution of this Assignment, at the request of the Assignee and at the Assignee's expense, but without additional consideration to the Assignor, the Assignor will execute and deliver to the Assignee from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Mark, to perfect

the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the Mark and to give full effect to this Assignment.

This Assignment is binding on the Assignor and its respective successors, heirs and assigns, and inures to the benefit of the Assignee and its successors and assigns.
