ASSIGNMENT

The foregoing Assignment includes any actions, claims and demands whatsoever, known or unknown, that Assignor may have or have had thereunder prior to the date of this Assignment, the same to be held and enjoyed by Assignee for its own use and benefit, and for the use and benefit of its successors, assigns, and legal representatives as full and entirely as the same would have been held by Assignor and this Assignment not been made. Assignor agrees to execute all documents and assignments and to perform such other acts as Assignee may reasonably request to secure to it the rights hereby conveyed.

2. Assignor shall duly execute and deliver or cause to be executed and delivered all instructs of sale, conveyances, transfer and assignment, and notices, releases, acquittances, and other documents and perform such further acts, as may be necessary to convey, transfer, assign and delivery to, and consolidate, vest and record in Assignee, full ownership of the Trademarks and other rights conveyed herewith.


