## ASSIGNMENT

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and the appropriate officers of all other jurisdictions in which the Marks are registered or in which applications included among the Marks are pending, to record the title of Assignee, its successors, legal representatives and assigns, as owner of all right, title and interest in and to the Marks, and to issue the Certificate of Registration resulting from any application concerning the Marks or renewal of any existing registration of the Marks to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.
