THIS ASSIGNMENT AND ASSUMPTION OF CONTRIBUTED ASSETS (this "Assignment") is entered into effective as of February 28, 2012, by and between Easy2Live, LLC, a California limited liability company ("Assignee") and POWRNAPS Retail Concepts Inc., a California Sub-S Corporation ("Assignor").

1. **Assignment and Contribution of Assets; Assumption.** Assignor hereby contributes, transfers, conveys and assigns all of its right, title and interest in the assets related to the Easy2Live supplement business, including, without limitation, those assets listed on **Schedule 1** attached hereto and incorporated by reference (the "Contributed Assets"). Assignee hereby assumes and agrees to perform all of Assignor's obligations arising with respect to the Contributed Assets, and assumes all liabilities and obligations relating to the Contributed Assets, arising after the date hereof.

2. **Representations and Warranties.** Assignor hereby represents and warrants to Assignee as follows: (i) it is the sole owner of the Contributed Assets; (ii) its interest in the Contributed Assets is free and clear of any liens or encumbrances; (iii) it has the full right, power, and authority to transfer its interest in the Contributed Assets to Assignee; (iv) it is a corporation duly organized and in good standing in the State of California; (v) it has taken all necessary corporate action to approve this assignment of assets; and (vi) the names, trademarks and other intangible assets that are part of the Contributed Assets do not infringe the intellectual property rights of any third party and no third party is infringing Assignor's intellectual property rights in such names, trademarks and other intangible assets.

3. **Successors and Assigns.** This Assignment is binding upon, and will inure to the benefit of, the parties hereto and their respective successors and assigns.
