## Trademark Security Agreement

**THIS TRADEMARK SECURITY AGREEMENT**, dated as of October 19, 2012 (this "Agreement"), is made by INSPIRED BEAUTY BRANDS, INC., a New York corporation ("IBB"), FDS ACQUISITION, INC., a Delaware corporation ("FDS"), and, together with IBB, collectively, the "Borrowers" and each, individually, a "Borrower"), and INSPIRED BEAUTY BRANDS HOLDINGS, INC., a Delaware corporation ("Holdings"), and, together with the Borrowers, collectively, the "Grantors" and each, individually, a "Grantor"), in favor of CRESTMARK BANK ("Crestmark").

**WHEREAS**, IBB, Holdings and Crestmark have entered into a Factoring Agreement dated February 12, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Factoring Agreement", including, without limitation, and re-documentation of the transactions among, *inter alia*, the Borrowers, Holdings and Crestmark in the form of a loan or otherwise); and

**WHEREAS**, FDS has guaranteed all obligations from IBB and Holdings to Crestmark pursuant to the terms of a certain Guaranty and Security Agreement from Corporation dated on or about the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty"); and

**WHEREAS**, in connection with the Factoring Agreement and the Guaranty the Grantors are executing and delivering this Agreement;

**NOW, THEREFORE**, in consideration of the premises, each Grantor hereby agrees as follows:

**Section 1 Defined Terms**. Capitalized terms used herein without definition are used as defined in the Factoring Agreement and the Guaranty.

**Section 2 Grant of Security Interest in Trademark Collateral**. Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of the Grantor, hereby pledges to the Crestmark, and grants to the Crestmark, a security interest in, all of its right, title and interest in, to and under the following, whether now owned or hereafter acquired or arising (collectively, the "Trademark Collateral");

- (i) all of its Trademarks, including those referred to on Schedule I hereto, but excluding any "intent to use" Trademark applications for which a statement of use has not been filed;
- (ii) all renewals and extensions of the foregoing;
- (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

**Section 3 Security Agreement**. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Crestmark pursuant to the Factoring Agreement and the Guaranty, and each Grantor hereby acknowledges and agrees that the rights and remedies of the Crestmark with respect to the security interest in the Trademark Collateral made and

granted hereby are more fully set forth in the Factoring Agreement and the Guaranty, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any conflict or inconsistency between this Agreement and the Factoring Agreement and the Guaranty (or any portion hereof or thereof), the terms of the Factoring Agreement and the Guaranty shall prevail.

**Section 4**      **Grantors Remain Liable.** Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Trademarks and Trademark Licenses subject to a security interest hereunder.






