3. This Bill of Sale is made under the terms of the Asset Purchase Agreement and is not in derogation of any of the rights which the Seller and the Buyer have under the Asset Purchase Agreement. In the event of any conflict or inconsistency between this Bill of Sale and the Asset Purchase Agreement, the Asset Purchase Agreement will prevail.
4. This Bill of Sale will be governed by and construed in accordance with the laws of the State of Illinois and the laws of the United States of America in that State.


