Pursuant to the provisions of the Texas Revised Limited Partnership Act ("the TRLPA") and Section 10.08 of the Texas Limited Liability Company Act ("the TLLCA"), the undersigned converting entity certifies the following articles of conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the TRLPA and the TLLCA.

1. A plan of conversion was approved and adopted in accordance with the provisions of Article 10.08 of the TLLCA providing for the conversion of Prime Storage, L.C., a limited liability company formed under the TLLCA, to Prime Storage, L.P., a Texas limited partnership.

2. An executed plan of conversion is on file at the principal place of business of the converting entity at 5306 Carew Street, Houston, Texas 77096, and, from and after the conversion, an executed plan of conversion will be on file at the principal place of business of the converted entity at 5306 Carew Street, Houston, Texas 77096.

3. A copy of the plan of conversion will be furnished by the converting entity (prior to the conversion) and the converted entity (after the conversion) on written request and without cost to any shareholder, partner, or member of either converting or converted entity.

4. Approval of the plan of conversion was duly authorized by all action required by the laws under which the converting entity was organized and by its constituent documents.

5. The entity created by the conversion will be liable for the payment of all fees and franchise taxes that might be owed by the entity being converted.

6. Two copies of the certificate of limited partnership of Prime Storage, L.P. which is being created pursuant to the plan of conversion, are being filed with the Secretary of State with these articles of conversion.
