- (1) PIRIFORM LIMITED a company registered in England with Company Number 05565433 whose registered office is at 78 York Street, London W1H 1DP ("Assignor")
- (2) PIRIFORM COMMERCIAL LIMITED a company registered in Cyprus with number HE 258272 and whose registered office is situated at Stasandrou, 20, 1<sup>st</sup> Floor, P.C. 1016 Nicosia, Cyprus ("Assignee")

**INTRODUCTION**

- A The Assignor is the legal and beneficial owner of the Assigned Intellectual Property Rights.
- B The Assignor has agreed to assign the Assigned Intellectual Property Rights to the Assignee on the terms set out in this assignment.

**THIS DEED WITNESSES THAT:**

**1 DEFINITIONS**

In this assignment the following words have the meanings set out below unless stated otherwise.

"Assigned Intellectual Property Rights" means the Intellectual Property Rights set out in Schedule 1.

"Encumbrances" means the following licences (as previously amended and varied):

- (i) the Software and Trade Mark Licence Agreement dated 7 January 2010 between the Assignor, the Assignee and Piriform Barbados Limited, including any sub-licences granted thereunder in accordance with its terms; and
- (ii) and all licences granted to end user customers in the ordinary course of the Assignor's business.

"Intellectual Property Rights" means patents, trade marks, service marks, trade names, trade or business names, copyright (including, but not limited to, rights in software), domain names, database rights, design rights, rights in confidential information and any other intellectual property rights whatsoever irrespective of whether such intellectual property rights have been registered or not which may subsist in any part of the world.

**2 ASSIGNMENT**

- 2.1 In consideration of the sum of five million, two hundred and forty thousand US dollars (\$2,400,000 USD), the Assignor hereby assigns to the Assignee with full title guarantee however subject to the Encumbrances all right, title and interest in and to the Assigned Intellectual Property Rights, including, without limitation, all statutory and common law

rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action.

2.2 The Assignor confirms that this assignment is made with the goodwill attaching to the Assigned Intellectual Property Rights.

### 3 FURTHER ASSURANCE

The Assignor shall, at the request of the Assignee or its nominee, do and execute or procure that there shall be done and executed in a form or manner reasonably satisfactory to the Assignee all such documents, deeds, matters, acts and things as the Assignee may at any time require to vest the Assigned Intellectual Property Rights or any part thereof in the Assignee or otherwise to give effect to this assignment and perfect the Assignee's title.

### 4 LAW AND JURISDICTION

4.1 This assignment shall be governed by and construed in accordance with English law.


4.2 Each party irrevocably agrees to submit to the exclusive jurisdiction of the courts of England in relation to any claim or matter arising under or in connection with this assignment.
