RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE dated November 13, 2012 by THE TORONTO-DOMINION BANK ("TD") with its mailing address at 77 King Street West, 18th Floor, Toronto, Ontario M5K 1A2, acting as collateral agent for the Secured Creditors defined in that certain Trademark Collateral Agreement referred to below (the "Agent");

WITNESSETH:

WHEREAS, Agent, and GARDA CL GREAT LAKES, INC., an Ohio corporation ("Debtor"), with its principal place of business and mailing address at 301 North Lake Avenue, Suite 600, Pasadena, California 91101, are parties to a certain Trademark Collateral Agreement dated March 12, 2010 which was recorded in the United States Patent and Trademark Office on May 6, 2010 at Reel 4200, Frame 0716, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations, and trademark applications listed on Schedule A-1 attached hereto and certain other property (collectively, the "Trademarks"); and

WHEREAS, the Debtor has requested that the Agent release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.


