AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
GLOBAL ALERTS, LLC

Pursuant to A.R.S. §29-633, the undersigned states as follows:

- A. The present name of the limited liability company is Global Alerts, LLC (the "Company").
- B. The date of filing of the initial Articles of Organization of the Company was June 29, 2006, at instrument no. L-1295244-3, under the name Global Security Alerts, LLC, which was amended to Global Alerts, LLC on December 11, 2006.
- C. The Articles of Organization are amended and restated in their entirety to read as follows:
 - 1. The name of the Company is i Recycle, LLC.
