## PATENT AND TRADEMARK ASSIGNMENT

THIS PATENT AND TRADEMARK ASSIGNMENT (this "Assignment") is made as of January 1, 2012 (the "Effective Date") between R.E. Whitaker Co., a Pennsylvania corporation ("Assignor"), and Whitaker Cleaning Systems, Inc., a Pennsylvania corporation ("Assignee"). Assignor and Assignee are sometimes collectively referred to herein as the "Parties" and each individually a "Party."

WHEREAS, Assignor owns the patents and patent applications listed in Exhibit A attached hereto and all inventions disclosed therein (the "Patent Rights"), and the trademarks listed in Exhibit B (the "Trademark Rights") (collectively the "Intellectual Property Rights"); and

WHEREAS, pursuant to this Assignment, Assignor has agreed to assign to Assignee, and Assignee has agreed to assume from Assignor, all of Assignor's right, title and interest in and to the Intellectual Property Rights;

NOW THEREFORE, for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignor hereby assigns to Assignee, and Assignee hereby accepts, all right, title and interest of Assignor in and to the Intellectual Property Rights and all other legal protection based thereon or obtainable herefore throughout the world, together with all rights of priority, in and to the Intellectual Property Rights as described and/or claimed in any and all applications for patents, including divisionals, continuations, renewals, substitutes and reissues thereof, and all rights of priority resulting from any of these patent applications, as well as all foreign counterparts and extensions thereof, together with all patents issuing on any of these applications, to be held and enjoyed by Assignee, for its own use and benefit, and for the benefit of its successors and assigns, to the full end of the terms of all of the patents which may be granted on the Intellectual Property Rights in this or any other country, as fully and entirely as the same would have been held by Assignee had this Assignment not been made, including, without limitation, the right to sue and collect for past infringement.

2. Assignor hereby divests itself of any and all rights it had in and to the Intellectual Property Rights and conveys them to Assignee, who shall hold such rights in place of Assignor, enjoying and benefiting from any and all the rights to the Intellectual Property Rights to the same extent as Assignor would have enjoyed and benefited therefrom, and taking Assignor's place in any and all claims, actions and obligations which may derive therefrom or relate thereto, including, without limitation, claims for infringement or violation of the Intellectual Property Rights that relate to actions that occurred prior to the Effective Date. Assignor hereby assigns to Assignee all its rights and obligations resulting from transactions between Assignor and any third party in connection with the Intellectual Property Rights.

3. Assignee shall henceforth have the right to consider itself the sole owner of the Intellectual Property Rights and to use or make any other disposal of the Intellectual Property Rights as it shall deem fit, without any further claim on the part of Assignor in any event or at any time.

4. Assignee shall be solely responsible for registering, recording or taking any other steps necessary to perfect this assignment of the Intellectual Property Rights to Assignor. Assignor agrees to cooperate fully with Assignee, upon Assignee's request and at Assignee's cost but without further consideration, in registering, recording or otherwise perfecting this assignment and procuring and enforcing the rights transferred hereby, including assisting with prosecution, providing or executing additional documentation, delivering any testimony in legal proceedings, making all rightful oaths, and

assisting with all lawful acts that may be required or assistance that may be reasonably required or desired upon request by Assignee. Assignee shall bear all costs related to the assignment of the Intellectual Property Rights.

5. As of the Effective Date, Assignee shall be solely responsible for maintaining and defending the Intellectual Property Rights.

6. This Assignment constitutes the entire agreement and understanding of the Parties with regard to the subject matter of this Assignment, and supersedes all previous communications, whether oral or written, between the Parties, and there are no further or other agreements or understandings, written or oral, in effect between the Parties, with respect to the subject matter of this Assignment.

7. This Assignment, and all amendments, modifications, alterations or supplements hereto, shall be construed under, governed by, and the legal relations between the Parties determined in accordance with, the laws of the Commonwealth of Pennsylvania, without reference to its choice of laws provisions. Any amendments, modifications, alterations, or supplements to this Assignment shall be made in writing to be legally effective.

8. If any one or more provisions of this Assignment is or becomes invalid, the Parties agree to replace said provisions with valid provisions that approximate, as closely as possible, the intent of the original provision. If the Parties cannot agree on one or more replacement provisions, the invalidity of any one or more provisions of this Assignment shall not affect the validity of this Assignment as a whole, unless the invalid provisions are of such material importance to the Assignment that it is reasonable to assume that the Parties would not have executed this Assignment without them.




