TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is dated as of December 19, 2012, and is made from Shihchung Albert Woo (“Assignor”), to Plexus Information Systems, Inc., a corporation organized and existing under the laws of the Commonwealth of Massachusetts (“Assignee”).

WHEREAS, Assignor is a founder of Assignee and is the owner of the trademark set forth in the attached Schedule A (the “Mark”); and

WHEREAS, Assignee wishes to acquire from Assignor, and Assignor wishes to transfer to Assignee, all of Assignor’s right, title and interest in the Mark and all of the goodwill associated with the Mark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment of Rights. Assignor hereby grants, assigns and transfers to Assignee all of Assignor’s right, title and interest in the Mark worldwide, together with the goodwill of the business symbolized by the Mark, all common law rights in the Mark, all registrations and applications for registration thereof, the right to sue, either at law or in equity, and the right to recover for any past, present or future infringements thereof and the right to initiate other proceedings before all government and administrative bodies with respect to the Mark.

2. Recordation. Assignor hereby requests the U.S. Patent and Trademark Office and the relevant trademark authority in any other country throughout the world to record this Trademark Assignment Agreement to Assignee. Assignor hereby further authorizes and requests the U.S. Patent and Trademark Office and any relevant trademark authority in any other country throughout the world to issue any and all trademark registrations resulting from any applications assigned hereunder to Assignee, or its successors and assigns, as assignee of Assignor’s entire interest therein and all goodwill symbolized thereby. Assignee will be responsible for any fees associated with such recordation of this Trademark Assignment Agreement.

3. General. This Trademark Assignment Agreement shall be binding upon and inure to the benefit of and be enforceable by the respective parties hereto and the successors and permitted assigns of Assignee, whether so expressed or not. This Trademark Assignment Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, with the same effect as if all parties had signed the same document. All such counterparts shall be deemed an original, shall be construed together and shall constitute one and the same instrument. This Trademark Assignment Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts, without regard to its conflict of law principles.
