TRADEMARK ASSIGNMENT

Effective as of December 1, 2012 ("Effective Date") WinPlast, LLC a Delaware limited liability company (the "Assignor") executes this Assignment of Trademarks (the "Assignment") in favor of Winkler Plastic, LLC a California limited liability company (the "Assignee") (each a "Party" and collectively the "Parties").

Assignor agrees to execute any additional documents necessary or reasonably requested by Assignee to effect or evidence the Assignment, and those documents reasonably requested by Assignee in order to apply for and obtain, in the Assignee's name and for its benefit, trademarks and all other intellectual property rights throughout the world related to the Trademark and to transfer, effect, confirm, perfect, record, preserve, protect and enforce all right, title and interest transferred hereunder (collectively, "Supporting Documents"). If Assignor fails or refuses to timely execute any Supporting Documents, Assignor hereby agrees, for itself and its successors, assigns, donees, and transferees, to the fullest extent permitted by law, that the Manager of Assignee is hereby, irrevocably appointed Assignor's attorney-in-fact with full authority to execute any Supporting Documents requested by Assignee, and to perform all other acts necessary to effect, perfect or evidence the Assignment.

This Assignment shall inure to the benefit of, and be binding upon, the successors, executors, administrators, legal representatives and assigns of Assignor and Assignee.

This Assignment shall be governed by and construed under the laws of the State of California, without regard to choice of laws provisions.
