BILL OF SALE, ASSIGNMENT AND ASSUMPTION AGREEMENT

- 2. <u>Assumption</u>. Nothing contained in this Agreement is intended by the parties to expand the rights and remedies of any third party against either party hereto as compared to the rights and remedies, which such third party would have had against such party, had the parties hereto not consummated this Agreement.
- 4. <u>Entire Agreement</u>. This Agreement contains the entire understanding between the parties hereto with respect to the transactions contemplated hereby and supersedes and replaces all prior and contemporaneous agreements and understanding, oral or written, with regard to such transactions.

In the event that part of this Agreement is declared by any court or other judicial or administrative body to be null, void or unenforceable, said provision shall survive to the extent it is not so declared, and all of the other provisions of this Agreement shall remain in full force and effect.
