**RELEASE OF  
GRANT OF SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**


**WHEREAS**, Axium Healthcare Pharmacy, Inc. **NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent terminates the Security Agreement and does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Administrative Agent's right, title and interest in and to the Patents and the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Patents and the Trademarks, and does hereby agree that the filing of the Patent and Trademark Security Interest in the United States Patent and Trademark Office as aforesaid may be removed of record.
