DECISION
on cancellation from the Register of Companies

On June 1, 2010, the District Court of Kranj, in the registration matter of cancellation from the Register of Companies

adopted the following decision:

The subject of entry ELAN, proizvodnja izdelkov za šport in prosti čas, d.o.o., registration number 5048770000 shall be cancelled from the Register of Companies.

The company shall be cancelled from the Register of Companies due to its merger to the absorbing company ELAN SKUPINA, holdinška družba, d.o.o., registration number 1304836000, based on the merger agreement of March 25, 2010.

Legal instruction:

An appeal may be filed against this decision within 8 days as of its publication. The appeal is to be filed with this court.

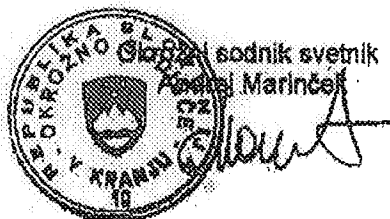

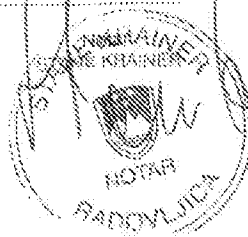
