the Trademarks that are within Assignor' s possession or control, and to provide further assurances and testimony on behalf of Assignee that lawfully may be required of Assignor in respect of the prosecution, maintenance and defense of any Trademarks encompassed within the terms of this instrument. Assignor' s obligations under this instrument shall extend to Assignor' s heirs, executors, administrators and other legal representatives.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all registrations for said Trademarks to Assignee, as the Assignee of the entire right, title and interest in and to the same, for Assignee' s sole use and behoof; and for the use and behoof of Assignee' s legal representatives and successors, to the full end of the term for which such trademark registration may be granted and for all renewal terms, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made.

Assignor and Assignee hereby authorize any and all individuals associated with Matthias Scholl, Inc. to insert or complete any information in this document needed to effect its recordal in the respective trademark offices and to record the same.


