BILL OF SALE AND ASSIGNMENT OF CONTRACT RIGHTS

1. **SALE AND TRANSFER OF ASSETS AND CONTRACT RIGHTS.** For good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, and as contemplated by Section 7 of that certain Dissolution and Winding Up Agreement dated December 28, 2012, STRONGLITE, LLC, a Delaware limited liability company ("Stronglite") hereby sells, transfers, assigns, conveys, grants and delivers to its sole member, EARTHLITE MASSAGE TABLES, INC., a California corporation ("Earthlite"), all of Stronglite's right, title and interest in and to all of its assets (the "Assets") and contract rights ("Rights") including without limitation the Assets and Rights described on Schedule A hereto (collectively, the Assets and the Rights being referred to as the "Transferred Items").

2. **POWER OF ATTORNEY.** Stronglite hereby constitutes and appoints Earthlite as its true and lawful agent and attorney in fact, with full power of substitution, including the following:

(a) to demand, receive and collect any and all of the Transferred Items and to give receipts and releases for and with respect to the same, or any part thereof;

(b) to institute and prosecute, in the name of Stronglite or otherwise, any and all proceedings at law, in equity or otherwise, that Earthlite or its successors and assigns may deem proper in order to collect or reduce to possession any of the Transferred Items and in order to collect or enforce any claim or right of any kind hereby assigned or transferred, or intended so to be; and

(c) to do all things legally permissible, required or reasonably deemed by Earthlite to be required to recover and collect the Transferred Items and to use Stronglite's name in such manner as Earthlite may reasonably deem necessary for the collection and recovery of same.

Stronglite hereby declares that the foregoing powers are coupled with an interest and are and shall be irrevocable by Stronglite.

IN WITNESS WHEREOF, Stronglite has executed this Bill of Sale and Assignment of Contract Rights effective as of December 31, 2012.
