**RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, pursuant to said Collateral Agreement and Security Interest, the Grantor granted to the Administrative Agent on behalf of the Lenders (as defined in the Security Interest), among other collateral, a continuing security interest in all of the Grantor's right, title and interest, in, to and under the United States trademarks listed on the attached Schedule A (the "Marks");


WHEREAS, said Security Interest was recorded in the United States Patent & Trademark Office on October 22, 2002, at reel/frame 2599/508; and
