ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this "Assignment") is made as of July 30, 2012, by Life Capitol AS, an entity organized under the laws of Norway ("LC"), and Intuitive Biosciences, Inc., a Wisconsin corporation ("Intuitive").

WHEREAS, LC and Intuitive are parties to that certain Subscription Agreement, dated as of July 30, 2012, pursuant to which LC has subscribed for shares of Intuitive and agreed to sign and deliver this Assignment.

NOW, THEREFORE, for and in consideration of the premises and mutual covenants contained herein, and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Assignment and Assumption. LC hereby assigns, sells, transfers, and sets over to Intuitive all of LC's worldwide right, title and interest in, to and under the intellectual property described on Schedule A hereto (the "Intellectual Property"), together with the goodwill of the business associated therewith and that is symbolized thereby, all rights to sue for infringement of any of the Intellectual Property, whether arising prior to or subsequent to the date of this Assignment, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect, the same to be held and enjoyed by Intuitive, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by LC had this Assignment not been made.

2. Governing Law. Except to the extent that federal law preempts state law with respect to the matters covered hereby, the laws of the State of Wisconsin govern all matters arising out of or relating to this Agreement, including, without limitation, its interpretation, construction, performance, and enforcement, without giving effect to such state's conflicts of law principles or rules of construction concerning the drafter hereof.

3. Further Actions. Each of the parties hereto covenants and agrees, at its own expense, to execute and deliver, at the request of the other party hereto, such further instruments of transfer and assignment and to take such other action as such other party may reasonably request to more effectively consummate the assignments and assumptions contemplated by this Agreement.

This Assignment is signed and effective as of July 30, 2012.
