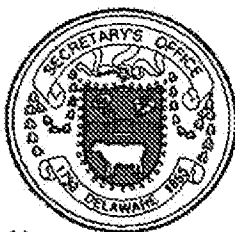

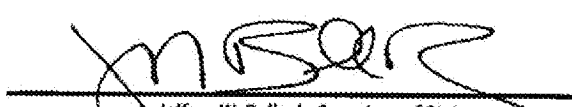

Pursuant to the provisions of Sections 263 and 264 of the General Corporation Law of the State of Delaware (the "DGCL") and Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), HWC Wire & Cable Company, a Delaware corporation ("HWCC"), does hereby certify that:

FIRST: The name and jurisdiction of formation or organization of each of the constituent entities to the merger are as follows:

SECOND: The Agreement and Plan of Merger, dated as of December ²⁷ 2010 (the "Plan of Merger"), by and among Southwest Wire Rope, LP, a Texas limited partnership ("SWWR LP"), Southwest Wire Rope GP LLC, a Delaware limited liability company ("SWWR GP"), Southern Wire, LLC, a Delaware limited liability company ("Southern Wire"), and HWCC, providing for the merger of SWWR LP, SWWR GP and Southern Wire with and into HWCC (the "Merger"), with HWCC as the surviving corporation (the "Surviving Entity"), has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with the requirements of the Texas Business Organizations Code, the DGCL and the DLLCA and their respective constituent documents.

THIRD: The name of the Surviving Entity is "HWC Wire & Cable Company," and it shall continue in existence under the laws of the State of Delaware.

FOURTH: The Merger shall become effective at 1:01 a.m. (Eastern Time) on January 1, 2011 (the "Effective Time").

FIFTH: The executed Plan of Merger is on file at an office of the Surviving Entity, the address of which is 10201 North Loop East, Houston, Texas 77029.


SIXTH: A copy of the Plan of Merger will be furnished by the Surviving Entity, on request and without cost, to any partner, member or stockholder of any constituent entity that is a party to the Merger.

SEVENTH: The Amended and Restated Certificate of Incorporation of HWCC as in effect immediately prior to the Effective Time shall be the Certificate of Incorporation of the Surviving Entity.
