
CONFIRMATORY TRADEMARK ASSIGNMENT

By virtue of transfer and assignment agreement entered into on April 19, 2012 by **Red Poppy Trading, LLC**, a California corporation that had its principal place of business at 101 Cooper Street, Santa Cruz, California 95060 and **Jafa, Inc.**, a California corporation, having its principal place of business at 101 Cooper Street, Santa Cruz, California 95060, the entire business of Red Poppy Trading, LLC, including the portion of the business to which the mark **JAJA** (US trademark application No. **85/555,980**, filed on February 29, 2012) pertains, was transferred and assigned to Jafa, Inc.

Karen Crivelli formed Red Poppy Trading, LLC, of which Karen Crivelli was the former President, CEO, and sole owner until its dissolution in July 2012; during the existence of Red Poppy Trading, LLC and before its dissolution: a) Red Poppy Trading, LLC filed the above-identified trademark application for the mark **JAJA**, with the United States Patent and Trademark Office based on its bona fide intent to use the mark in commerce; b) Karen Crivelli formed Jafa, Inc., to succeed Red Poppy Trading, LLC; Karen Crivelli is the current President, CEO, and sole owner of JAJA, Inc.; and c) The entire business of Red Poppy Trading, LLC, including the portion of the business to which the mark **JAJA** pertains, was transferred and assigned to Jafa, Inc. by virtue of agreement between Red Poppy Trading, LLC and Jafa, Inc., which is confirmed herein.

Therefore, Karen Crivelli on behalf of Red Poppy Trading, LLC confirms that Red Poppy Trading, LLC assigned all rights, title and interest in and to the above-identified mark **JAJA** to Jafa, Inc., on April 19, 2012, including the right to damages for infringement committed before such assignment, and together with the goodwill of the business symbolized by the mark **JAJA** for good and valuable consideration, as part of the entire business and portion thereof to which the mark pertains, and said business is ongoing and existing in Jafa, Inc., as required by 15 USC § 1060. The present confirmation of assignment is thus being made for the purpose of recording Red Poppy Trading, LLC original intent to assign the mark **JAJA**, and perfecting the chain of title to the current owner Jafa, Inc. as of **April 19, 2012** with the United States Patent and Trademark Office.
