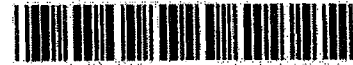

**CERTIFICATE OF
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
E2020, INC.**

Pursuant to the provisions of Nevada Revised Statutes 78.390 and 78.403, the undersigned officer of E2020, Inc., a Nevada corporation (the "*Corporation*"), does hereby certify as follows:

- A. The board of directors of the Corporation duly adopted resolutions proposing to amend and restate the articles of incorporation of the Corporation as set forth below, declaring said amendment and restatement to be advisable and in the best interests of the Corporation.
- B. The amendment and restatement of the articles of incorporation as set forth below have been approved by at least a majority of the voting power of the outstanding shares of voting common stock, which is sufficient for approval thereof.
- C. This certificate sets forth the text of the articles of incorporation of the Corporation as amended and restated in their entirety to this date as follows:

**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
E2020, INC.**

**ARTICLE I
NAME**

The name of the corporation is Edgenuity Inc. (the "*Corporation*").

**ARTICLE II
AUTHORIZED STOCK**

The Corporation shall have authorized capital stock consisting of 1,000 shares of common stock, with no par value per share.

**ARTICLE III
EXCULPATION**

(a) Limitation on Liability. The liability of directors and officers of the Corporation shall be eliminated or limited to the fullest extent permitted by the Nevada Revised Statutes. If the Nevada Revised Statutes are amended to further eliminate or limit or authorize corporate action to further eliminate or limit liability of directors or officers, the liability of directors and officers of the Corporation shall be eliminated or limited to the fullest extent permitted by the Nevada Revised Statutes, as so amended from time to time. Notwithstanding the foregoing, this

Article III shall not eliminate or limit the liability of a director for any act or omission occurring prior to the date when this Article III becomes effective or resulting from gross negligence, fraud or willful misconduct.

(b) Repeal and Modification. Any repeal or modification of Section (a) of this Article III approved by the stockholders of the Corporation shall be prospective only, and shall not adversely affect any limitation of the liability of a director or officer of the Corporation existing as of the time of such repeal or modification. In the event of any conflict between Section (a) of this Article III and any other Article of these Amended and Restated Articles of Incorporation, the terms and provisions of Section (a) of this Article III shall control.

ARTICLE IV COMBINATIONS WITH INTERESTED STOCKHOLDERS

At such time, if any, as the Corporation becomes a "resident domestic corporation", as that term is defined in Nevada Revised Statutes 78.427, the Corporation shall not be subject to, or governed by, any of the provisions in Nevada Revised Statutes 78.411 to 78.444, inclusive, as may be amended from time to time, or any successor statutes.
