TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made effective as of December 20, 2012, between THE VOLLRATH COMPANY, LLC, a Wisconsin limited liability company ("Assignee") and ACRY FAB, INC., a Wisconsin corporation ("Assignor").

RECITALS

A. Assignor has adopted and used in its business, is the owner of the United States trademark applications and registrations, and is the owner of the worldwide (excluding the United States) trademark applications and registrations of the trademarks identified in and listed on Exhibit A attached hereto and made a part hereof (collectively the "Trademarks"); and

B. Assignee is acquiring all right, title and interest in and to said Trademarks in accordance with a certain Asset Purchase Agreement by and among Assignor, Assignee and JEFF GUNDERSON AND RANDY SCHLUPP dated the date hereof (the "Purchase Agreement").

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign, transfer and convey unto Assignee all of its right, title and interest in and to the Trademarks, together with the good will symbolized by and associated with the business in connection with which the Trademarks are used, all income, royalties, and payments now or hereafter due or payable in respect thereto, and all causes of action either in law or equity, for past, present or future infringement based upon the Trademarks. Assignor agrees to promptly deliver to Assignee copies of its and its trademark attorneys' files (except to the extent such files include privileged information, which may be retained by Assignee and/or its trademark attorneys) relating to applications for registration of any of the Trademarks with applicable government agencies.

2. Assignor shall duly execute and deliver or cause to be executed and delivered all instruments of sale, conveyance, transfer and assignment, and all notices, releases, acquittances and other documents that may be necessary more fully to grant, convey, transfer, assign and deliver to and vest in Assignee the Trademarks hereby granted, conveyed, transferred, assigned and delivered or intended so to be (the "Additional Transfer Documents"). Assignee shall cooperate with Assignor and provide information as necessary to Assignor to complete the Additional Transfer Documents. Assignor shall complete the transfer of ownership of the Trademarks to Assignee and provide written acknowledgment to Assignee confirming completion of the confirmation of transfer of ownership and deliver the Additional Transfer Documents to the Assignee within fifteen (15) calendar days of the date of this Assignment. To the extent Assignor has not complied with the schedule set forth in this paragraph, Assignor irrevocably appoints the Assignee as its attorney-in-fact with the right, authority and ability to execute and enter into such transfer on behalf of the Assignor. Assignor stipulates and agrees that such appointment is a

right coupled with an interest and will survive unavailability or dissolution of the Assignor at any future time.

3. Assignor further agrees to execute further documents and take further actions as may be reasonably required to ensure the Assignee's ownership of the Trademarks.

4. Assignor further agrees that it shall not, now or in the future, use the Trademarks. Further, Assignor agrees that it shall not challenge Assignee's right, title, or interest in and to the Trademarks, including the right of Assignee in and to its current and/or future registrations and applications for such Trademarks, or seek to obtain or maintain state or Federal trademark registrations for the Trademarks or any mark or name similar thereto.

5. This Assignment may be executed in one or more original, facsimile or other electronic signature counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.

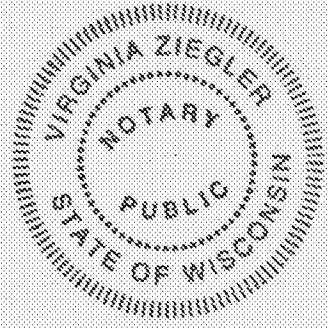

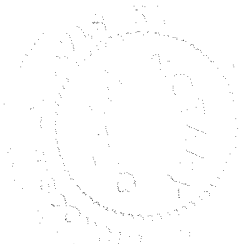
