TRADEMARK ASSIGNMENT

WHEREAS, consistent with the transfer from Assignor to Assignee of all goodwill and assets owned by Assignor, Assignee is desirous of acquiring, and Assignor is desirous of transferring, the entire right, title and interest in and to the Marks, the Intellectual Property and the goodwill of the business in connection with which the aforesaid Marks and Intellectual Property have been used;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks, together with the Intellectual Property and the goodwill of the business connected with the use of the Intellectual Property and the use of and symbolized by the Marks, and all claims, if any, which may have arisen there under prior to the date of this instrument.
