WHEREAS, Assignor has agreed to transfer to Assignee all of Assignor’s right, title and interest in and to the trademarks listed in Attachment A together with the goodwill of the business symbolized by the trademarks, pursuant to that certain Asset Purchase Agreement by, among others, Assignor and Assignee, dated January 31, 2013.

1. Assignor hereby assigns, transfers and conveys to Assignee, and Assignee hereby accepts and assumes, free and clear of any encumbrances, all right, title and interest in and to the trademarks as described on Attachment A hereto, together with the goodwill of the business symbolized by the trademarks, the applications for registration and registrations therefor, and all claims for damages arising out of or relating to past or continuing infringements thereof, if any, with the right to sue for and collect such damages.
2. The rights assigned hereby include, without limitation all of Assignor’s right to sue and recover for any past, present and future infringement or unauthorized use of any right or interest in the trademarks.
3. Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States Patent and Trademark Office, and any foreign trademark authority, to record this Assignment and hereby represent and warrant that Assignor has the full right to convey the entire interest herein assigned.
4. Assignor agrees to execute any further lawful documents and take any other actions that Assignee may consider necessary or appropriate to fully protect and vest in Assignee the assigned rights and interests in the trademarks and to assist Assignee in the registration, maintenance, perfection and enforcement of any of the trademarks.
5. This Agreement shall be governed by, and construed in accordance with the laws of the State of New York without giving effect to conflicts of law principles thereof.
6. This Assignment constitutes the entire agreement between the Parties with respect to the subject matter of this Assignment and supersedes all prior agreements and understandings, both oral and written, between the parties with respect to the subject matter of this Assignment.



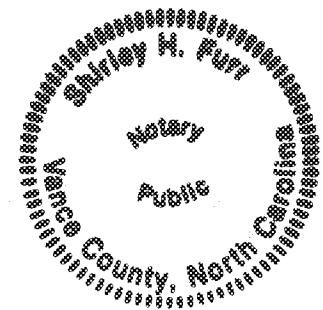
