(a) except as provided in this Assignment and except as may have occurred pursuant to any written agreement or other arrangement solely by and between Assignor and Assignee, (i) Assignor has not sold, transferred, assigned, encumbered, pledged, hypothecated, or otherwise disposed of, whether by gift or for consideration, the Registration, and (ii) the Registration is free and clear of any liens, encumbrances, licenses, or claims of any nature whatsoever;


(b) Assignor has made no agreement with respect to the Registration that is in conflict with this Assignment; and
