TRADEMARK ASSIGNMENT

WHEREAS NAUTICA APPAREL, INC., a Delaware corporation, with its principal place of business located at 40 West 57th Street, New York, New York 10019 (hereinafter "Assignor"), has adopted and used the trademark ENCOUNTER (hereinafter "ENCOUNTER") and is the record owner, beneficial owner or successor-in-interest to certain trademark registrations therefor, including those listed on Annex A hereto (hereinafter "Registrations"); and

WHEREAS Coty Geneva SA., a Switzerland corporation, with its principal place of business located at 87 Rue de Lyon, Geneva 1211, Switzerland (hereinafter "Assignee") is desirous of acquiring all rights, title and interest in and to ENCOUNTER, the goodwill symbolized thereby and the Registrations.

NOW THEREFORE IT IS AGREED AS FOLLOWS

For and in consideration of the sum of Thirty Five thousand US Dollars (US\$35,000.00) to be paid to Assignor upon execution of this Agreement by both parties, the receipt and sufficiency whereof is hereby mutually acknowledged, Assignor hereby sells, assigns, transfers and conveys unto said Assignee, its successors and assigns, the entire right, title and interest in and to ENCOUNTER, the goodwill symbolized thereby and the Registrations, including the right to sue for past and present infringements thereof.

Assignor represents and warrants that (i) it has the full right, power and authority to enter into this Agreement and to assign the rights to ENCOUNTER and the Registrations hereunder (ii) its rights in the Registrations are valid, enforceable and subsisting, and (iii) Assignor is not aware of any third party claims against ENCOUNTER or the Registrations.

Assignor hereby agrees to execute any assignment, power of attorney or other document that may be required to effectuate the transfer of ownership as contemplated herein to Assignee or its designee and recordation of the assignment on the relevant Trademark Registries (including by recording the 2007 assignment of rights in ENCOUNTER and the Registrations from Victoria's Secret Stores Brand Management, Inc. ("Victoria's Secret") to Assignor and/or facilitating a direct assignment from Victoria's Secret to Assignee, where applicable).

Assignor undertakes not to use or seek trademark registrations for ENCOUNTER or any ENCOUNTER composites, variations or derivatives and agrees not to challenge the use, validity or ownership of ENCOUNTER and the Registrations by Assignor, its Affiliates, successors, licensors and/or assigns.

This Agreement is effective as of February 7, 2012.


