**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of FEBRUARY 15, 2013 ("Effective Date") by Credit Suisse AG, Cayman Islands Branch as Administrative Agent and Collateral Agent ("Credit Suisse"), in favor of Hawker Beechcraft Corporation (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Pledge and Security Agreement by and between Grantor, certain of its affiliates, and Credit Suisse dated as of March 26, 2007 (the "Security Agreement"), the Grantor and certain of its affiliates granted to Credit Suisse a security interest in certain property, including certain Intellectual Property (as defined in the Security Agreement) including the United States trademark registrations and trademark applications set forth on Schedule 1 attached hereto (collectively, the "Trademark Collateral");

**WHEREAS**, in connection with the Security Agreement, the Grantor and Credit Suisse entered into the Trademark Security Agreements dated March 26, 2007 and May 6, 2010 (the "Trademark Security Agreements");

**WHEREAS**, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on April 2, 2007 at Reel 003512, Frame 0381 and on May 13, 2010 at Reel 004205, Frame 0536; and

**WHEREAS**, pursuant to the Amended Joint Plan of Reorganization of the Grantor and each of its debtor affiliates filed under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York, Credit Suisse is releasing its security interest in the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Credit Suisse hereby absolutely, unconditionally and irrevocably terminates the Trademark Security Agreements, and hereby terminates, cancels, discharges and releases any and all pledges and security interests it has in, upon or against the Trademark Collateral.

Administrative Agent shall take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, at the Grantor's expense.




