**GRANT OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS
(SECOND LIEN)**

Dated as of March 4, 2013

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Solo Cup Company LLC, a Delaware limited liability company (the "Grantor") with principal offices at 500 Hogsback Road, Mason, Michigan 48854, hereby grants to Wilmington Trust (London) Limited, as Second Lien Collateral Agent, with principal offices at Third Floor, 1 King's Arms Yard, London EC2R 7AI, United Kingdom (the "Grantee"), (i) a second priority security interest in all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, together with (ii) all Proceeds (as such term is defined in the Second Lien Security Agreement referred to below) of the Marks, (iii) the goodwill of the businesses symbolized by the Marks and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the full and prompt performance and payment of all the Grantor's Co-Issuer Second Lien Secured Obligations, as such term is defined in the Second Amended and Restated Second Lien Security Agreement between the Grantor, the other grantors from time to time party thereto and the Grantee, dated as of December 31, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Second Lien Security Agreement"). Upon the occurrence of the Second Lien Termination Date (as defined in the Second Lien Security Agreement), the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks acquired under this Grant of Security Interests to the Grantor.

THIS GRANT has been granted in conjunction with the security interests granted to the Grantee under the Second Lien Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are more fully set forth in the Second Lien Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interests are deemed to conflict with the Second Lien Security Agreement, the provisions of the Second Lien Security Agreement shall govern.
