I, Loyd Ivey, affirm that the following are statements of facts:

1) I was the President, Secretary, Treasurer, and majority stockholder of Soundcraftsmen, Inc. beginning on December, 12, 1990.

2) Soundcraftsmen, Inc. was the owner of the SOUND CRAFTSMEN trademark when it was registered on June 23, 1992 having registration number 1695882.

3) On January 1, 1994, the ownership of the SOUND CRAFTSMEN trademark devolved to Mitek Corporation DBA MTX as a result of a merger between Soundcraftsmen, Inc. and Mitek Corporation,.

4) On January 1, 1994, I executed an assignment of the SOUND CRAFTSMEN trademark from Soundcraftsmen, Inc. to Mitek Corporation DBA MTX which mistakenly identified myself, Loyd Ivey, as the assignor instead of correctly identifying Soundcraftsmen, Inc. as the assignor.


5) A corrective assignment is required to show that the correct assignor was Soundcraftsmen, Inc..

5) The assignment to Mitek Corporation DBA MTX was recorded on December 10, 1997.

6) Mitek Corporation DBA MTX is the current owner of trademark registration 1695882.
