## ASSIGNMENT OF TRADEMARK RIGHTS

NOW, THEREFORE, in consideration of the payment of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees to and does hereby irrevocably convey, transfer, assign, deliver, and contribute to Assignee all of Assignor's right, title, and interest in, to, and under the Trademark Rights, together with (1) the goodwill of the business of Assignor in connection with which the Trademark Rights are used and which is symbolized by the Trademark Rights; (2) all income, royalties, damages, and profits hereafter due or payable to Assignor with respect to the Trademark Rights, including without limitation, damages, profits, and payments for past, present, and future infringements and misappropriations of the Trademark Rights; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Trademark Rights.

Assignor hereby authorizes the respective officials whose duty it is to issue trademark rights to issue and maintain the Trademark Rights in the name of Assignee or as otherwise directed by Assignee.

Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in, to, and under the Trademark Rights.

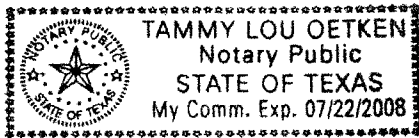
