## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment ") is effective as of March 22, 2013 by Jim Buckley, an individual citizen of the United States and Mitchell Clark, an individual citizen of the United States, (collectively "Assignors"), in favor of T.G.I.C. ### RECITALS

Assignors are the former owners of the trademark "Nobilissima" for wine (the "Trademark"). The Trademark was registered on the Principal Register of the U.S. Trademark Office on January 1, 2008 and assigned registration No. 3,362,968. Assignors and Assignee previously entered into that certain Assignment dated February 27, 2013, by which Assignors previously sold, transferred and assigned to Assignee, the Trademark and all the goodwill of the business to which the Trademark pertains and Assignee became the successor to Assignor in regard to that business. By this agreement, the parties desire to re-confirm the assignment of the Trademark and all goodwill of the business associated with the Trademark and all rights in and to the Trademark as well as the trademark registration to Assignee.

### AGREEMENT

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignors hereby sell, assign and transfer to Assignee, and re-affirm the sale, assignment and transfer to Assignee, without any reservation of rights, all of Assignors' right, title and interest in and to the Trademark and the trademark registration together with all the goodwill of the business symbolized by the Trademark.
