## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of April 15, 2013, is made by Canadian Imperial Bank of Commerce, New York Agency, as Administrative Agent for the Secured Parties (the “**Secured Party**”). Capitalized terms not otherwise defined herein shall have the meanings given to them in the Pledge and Security Agreement (as defined below).

**WHEREAS**, reference is made to that certain U.S. Pledge and Security Agreement dated as of September 28, 2012 (as amended, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”), made by the Grantors in favor of the Secured Party for the benefit of the Secured Parties;

**WHEREAS**, in connection with the Pledge and Security Agreement, Southern Air Inc., a Delaware corporation (the “Grantor”) and the Secured Party entered into that certain Trademark Security Agreement, dated as of September 28, 2012 (the “Trademark Security Agreement”), in which the Grantor granted a security interest in all of Grantor’s right, title and interest in and to the Secured Trademarks (as defined in the Trademark Security Agreement) including those trademarks and trademark applications owned or held by the Grantor listed on Schedule A attached hereto (collectively, the “Trademarks”); and

**WHEREAS**, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on October 2, 2012 at Reel/Frame No. 4870/0951.

**NOW THEREFORE**, the Secured Party hereby releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its security interest in the Secured Trademarks and the Trademarks and the Secured Party hereby reassigns any and all such right, title and interest (if any) that the Secured Party may have in the Secured Trademarks and the Trademarks to the Grantor.


The Secured Party authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
