RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY

The Patent Agreement was also duly recorded on October 12, 2001, at Patent Reel/Frame 012219/0940 in the United States Patent and Trademark Office, and pursuant to which the Grantor granted to Bank a security interest in and to all of Grantor's right, title and interest in and to certain patents and patent applications, including those specific patents and/or patent applications listed on Exhibit B attached hereto (the "Released Patents").

Bank wishes to release and retransfer to Grantor, without representation or warranty, all of Bank's right, title and interest in and to the Released Marks, and the goodwill associated therewith, and the Released Patents.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Bank, on behalf of itself and the lenders, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks and the Released Patents, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Bank, all of Bank's right, title and interest in and to the Released Marks, the goodwill associated therewith, the Released Patents, and all causes of action for past infringement, if any.
