(1) the right to bring and maintain any action worldwide for any and all claims, demands, and causes of action for past infringement of the Trademarks, including the right to recover damages, fees and other remedies worldwide of every kind recoverable at law or in equity or otherwise, for any and every infringement of such Trademarks; and

(2) the right to apply for, prosecute and obtain trademark registrations worldwide, or similar rights of protection, for the Trademarks and the goodwill associated with the Trademarks, including the right to claim priority from any application relating to the Trademarks.

Assignor agrees that Assignee may record this Trademark Assignment Agreement in any trademark office worldwide, where it will be open for public inspection. This Assignment is subject to and with the benefit of the "Purchase Agreement By And Between MF Lightwave, Inc. and CVC CCI Holdings, Inc." dated October ____, 2012, entered into between Assignor and Assignee, and receipt and sufficiency of good and valuable consideration is hereby acknowledged by Assignor.

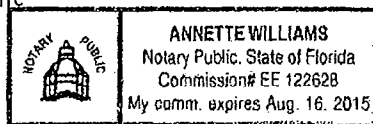

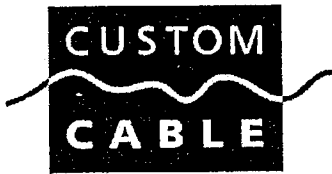

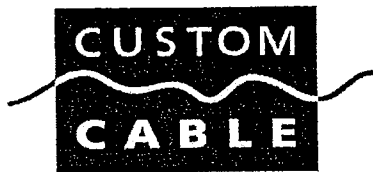
