
ASSIGNMENT OF TRADEMARKS



Assignor hereby agrees to, from time to time, execute and deliver to Assignee any such additional instruments, documents, conveyances or assurances and take any such other action as shall be necessary, suitable, or otherwise reasonably be requested by Assignee, to confirm and assure the rights and obligations, and render effective, the consummation of the transactions contemplated hereby and thereby, or otherwise to carry out the intent and purposes of the this Assignment. This instrument constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter hereof, whether oral or written.
