U.S. Trademark Assignment

ASSIGNMENT made this 3rd day of May, 2013, by Aviva Capland, an individual with an office and place of business located at 66 Water Street, Suite 3-C, Brooklyn, New York 11201 ("Assignor").

WHEREAS, Assignor is the owner of and has adopted U.S. Registration No. 3,710,224 for the mark THIRTEEN RATTLES and U.S. Registration No. 3,771,061 for the mark R 13 (hereinafter referred to as the "Marks"); and,

WHEREAS, 13 Rattles, Inc., a New York corporation, with an office and place of business located at 550 Broadway, 4th Floor, New York, New York 10012 ("Assignee") wishes to acquire Assignor's right, title, and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used; and,

WHEREAS, Assignor wishes to assign the Marks together with the goodwill of the business in connection with which the Marks are used to Assignee.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee all of it's existing and future rights, title and interest in and to the Marks together with the goodwill of the business in connection with which said Marks are used including the subject matter of all claims which may be obtained therefrom for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by said Assignor if this assignment had not been made.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the owner of the entire right, title and interest in and to the Marks, for the sole use and enjoyment of the Assignee, its successors, assigns or other legal representatives.

Assignor warrants and represents that the Marks have not been previously assigned or encumbered in any manner and that it is free and clear of all liens and claims.

Assignor shall further render such other assistance as may be reasonably required by Assignee to record his ownership rights of the Marks in the United States.
