**ASSIGNMENT OF TRADEMARKS AND
TRADEMARK REGISTRATION RIGHTS**

WHEREAS, Trynex, Inc., a Michigan corporation doing business as Trynex International (“Seller”), is the owner of the registered trademarks, trademark applications, common law trademarks and service marks set forth on the attached Exhibit A, along with other common law trademarks and service marks and trade names that constitute “Business Intellectual Property Rights” under the Purchase Agreement (the “Trademarks”), and Seller or its predecessor(s) in interest has adopted, has used and is using the Trademarks; and

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of May 6, 2013 (the “Purchase Agreement”), among Seller, the shareholders of Seller and Acquisition Tango LLC, a Delaware limited liability company to be renamed Trynex International LLC (“Buyer”), Buyer has agreed to acquire from Seller, and Seller has agreed to transfer to Buyer, all of Seller’s right, title and interest in and to the Trademarks along with the goodwill of the business symbolized by the marks and the identified registrations.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby sells, assigns and transfers to Buyer and its successors and assigns Seller’s entire right, title and interest in and to, and the use of, the Trademarks and all renewals thereof, together with (a) the goodwill of the business symbolized by the Trademarks and (b) all claims and demands that Seller (either itself or through its predecessor(s)) may have, at law or in equity, whether presently known, unknown, accrued or to accrue, arising out of past or present infringements of the Trademarks, including, without limitation, the right to recover all claims for damages and compensation. Such right, title and interest shall be held and enjoyed by Buyer and its successors and assigns as fully and entirely as the same would have been held and enjoyed by Seller if this sale, assignment and transfer had not been made.

The provisions of this instrument are subject, in all respects, to the terms and conditions of the Purchase Agreement, including, without limitation, all of the covenants, representations and warranties contained therein, all of which shall survive the execution and delivery of this instrument to the extent indicated in the Purchase Agreement. Nothing contained in this instrument shall be deemed to modify, amend or supersede any of the terms or conditions of the Purchase Agreement. In the event of any conflict or inconsistency between the terms and conditions of this instrument and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall prevail. This instrument shall be binding upon Seller and its successors and assigns, and shall inure to the benefit of Buyer and its successors and assigns.
