TRADEMARK SECURITY RELEASE

TRADEMARK SECURITY RELEASE, dated as of May 16, 2013, made by GEMCAP LENDING I, LLC, a Delaware limited liability company with offices at 24955 Pacific Coast Highway, Suite A202, Malibu, California 90265 ("Lender") in favor of OTZ SHOES, INC., a California corporation, with its principal place of business located at 24955 Pacific Coast Highway, Suite A103, Malibu, California 90265 ("Grantor").


