This Assignment shall be effective on the 4th day of September, 2012.

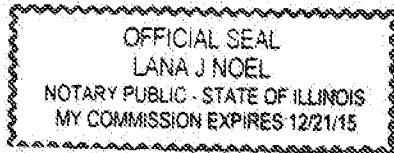

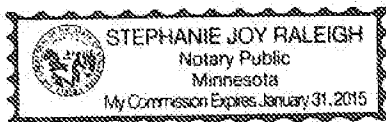
