**AMENDED ARTICLES OF ORGANIZATION
OF
LASER PHARMACEUTICALS, LLC**
(changing its name hereby to Zylera Pharmaceuticals SC, LLC)

Pursuant to S.C. Code of Laws §33-44-204(a), the undersigned limited liability company adopts the following Amended Articles of Organization:

1. The name of the limited liability company immediately prior to the effectiveness of this filing is Laser Pharmaceuticals, LLC.

2. The date the Articles of Organization were filed is August 16, 2005.

3. The Articles of Organization are amended in the following respects, of which all amended provisions may lawfully be included in the Articles of Organization.

(a) Paragraph 1 of the Articles of Organization are amended by removing the current language therein and replacing it with the following:

“1. The name of the limited liability company, which complies with S.C. Code of Laws §33-44-105, is: Zylera Pharmaceuticals SC, LLC (the “*Company*”).”

(b) Paragraph 5 of the Articles of Organization are amended by removing the current language thereof and replacing it with the following:


“5. The Company is **not** a term company.”

4. The amendments contained in these Amended Articles of Organization have been approved as required under S.C. Code of Laws §§33-44-101 et seq. (the “*South Carolina Limited Liability Act*” and the Operating Agreement of the Company).

5. These amended articles of organization shall be effective upon filing.

These Amended Articles of Organization have been executed, delivered and filed by an authorized Manager of the Company as of this, the 11th day of March, 2013.
